Purpose:

To communicate PY21 and FY22 Workforce Development Area (WDA) allotments for the Workforce Innovation and Opportunity Act (WIOA) Title I-B Youth, Adult, and Dislocated Worker programs and Title III Wagner-Peyser Employment Service and Workforce Information grants following issuance of [Training and Employment Guidance Letter \(TEGL\) 19-20](#).

Action Required:

Change 5 communicates the deobligation and redistribution of PY21 Title 1-B Dislocated Worker funds from WDA 3 to WDAs 2, 4, 6, 7, and 9 (see [Attachment A](#)).

Change 4 communicated the deobligation and redistribution of PY21 Title I-B Youth funds from WDA 3 to WDAs 1, 2, 4, 6, 8, 10, 11 and 12.

Per Change 3, Washington received from the U.S. Department of Labor an additional allotment of \$2,316 in its PY21 state WIOA Title I-B Dislocated Worker grant per a federal recapture and redistribution of unobligated WIOA Title I-B Dislocated Worker funds from Oklahoma announced in Training and Employment Guidance Letter (TEGL) [7-21](#).

Per Change 2, PY21/FY22 project codes were corrected.

Per Change 1, Local Workforce Development Boards (LWDBs) received draft grant packages from ESD's Grants Management Office.

LWDBs and their WIOA Title I-B service providers must distribute this guidance broadly throughout the system to ensure that WorkSource System staff are familiar with its content and requirements.
