**SUBJECT:** Program Year 2021 Workforce Innovation and Opportunity Act (WIOA) Title I-B Youth, Adult and Dislocated Worker Federal Award Terms

**Purpose:**

To communicate the publication of the PY21/FY22 Federal Award Terms established by the U.S. Department of Labor’s Employment and Training Administration for Workforce Innovation and Opportunity Act (WIOA) Title I-B Youth, Adult, and Dislocated Worker grant allotments.

These Federal Award Terms are incorporated by reference into all Title I-B grants to local workforce development boards (LWDBs) and other subrecipients and are available on the Workforce Professional Center website at <https://wpc.wa.gov/grants/WIOA>.

All expenditures of PY21/FY22 WIOA Title I-B funds must comply with these Federal Award Terms. This includes all expenditures of local Youth, Adult, Dislocated Worker, and Administrative Cost Pool subawards as well as all expenditures of Statewide Rapid Response and Statewide Activities subawards.

**Action Required:**

All WIOA Title I-B (sub)recipients, including LWDBs and their WIOA Title I-B subrecipients, must read and abide by these Federal Award Terms. Pursuant to Uniform Guidance, LWDBs must conduct monitoring and oversight of all subawards and subrecipients which includes, but is not limited to, monitoring for compliance with these Federal Award Terms.

LWDBs and their Title I-B subrecipients must distribute this guidance and these Federal Award Terms broadly throughout the system to ensure that WorkSource System staff are familiar with its content and requirements.

**Content:**

The U.S. Department of Labor’s Employment and Training Administration issued to Washington the Federal Award Terms that govern all federal funds allotted to the state and its subrecipients under Title I-B of WIOA.

At the request of LWDBs, the Employment Security Department prepared a red-line comparison of PY20/FY21 and PY21/FY22 WIOA Title I-B Federal Award Terms, which identifies key changes.
