SUBJECT: SKIES Changes and Data Capture Requirements

Purpose:

To introduce SKIES functional changes and new data capture requirements, effective June 30, 2014, in response to Training and Employment Guidance Letters (TEGLs) 17-05 and 4-13, WorkSource Policy 1002 (Common Measures), and recent data integrity efforts.

NOTE: The changes communicated through this WorkSource Information Notice (WIN) represent one piece of an ongoing effort to modify systems (e.g., SKIES) and reports to improve data integrity and align with federal requirements. Additional changes will be communicated in the near future through the Common Measures Policy and Handbook. The future Common Measures handbook will consolidate and streamline all existing performance policy and guidance documents, including this WIN.

Action Required:

Workforce Development Councils (WDCs) and their contractors, as well as Employment Security Regional Directors, must distribute this guidance broadly throughout the system to ensure that staff and partners in the WorkSource System are familiar with its content and requirements.

Staff and partners are expected to attend the upcoming federal and state sponsored webinar in July, 2014 to discuss the rationale for the ongoing data integrity effort, including specific Data Element Validation (DEV) findings and required corrective action.

Content:

1. Background

Since the inception of WIA in 1998, at the request of Congress, the Government Accountability Office (GAO), Office of the Inspector General (OIG) and other monitoring/auditing entities have reviewed the WIA performance and participant reports in order to ascertain the accuracy and authenticity of the data reported. Multiple reviews have concluded that significant problems exist in accuracy, quality and integrity of the data reported to Congress. These findings have resulted in the development of national initiatives

designed to improve the quality of workforce investment data. One of these initiatives is the state and local level Data Validation review conducted on an annual basis.

Within Washington and consistent with findings at the national level, the Employment Security Department (ESD) and Department of Labor (DOL) Region 6 have identified the need to increase the data integrity of Washington's report submissions, and modify SKIES to conform with federal requirements.

These changes are necessary to ensure compliance with TEGL 17-05 which places an emphasis on service based exits and recognition of point-in-time services (workshops, career counseling, etc.), in addition to services provided over a duration of time (occupational skills training, work experiences, etc.). TEGL 17-05 specifically requires that participants, who have not received a qualifying service in 90 days, be exited from the program. Both the 2012 Comprehensive Review and the 2013 Data Validation Review identified multiple instances where participants were not exited, as required, after 90 days following the last qualifying service received. Subsequent analysis of participant records within SKIES revealed that approximately 3,200 participants should be exited due to lack of receipt of a qualifying service.

Federal regulations require that all activities funded through Department of Labor (DOL) grants must be captured and reported consistently, and reporting requirements have gradually increased in detail (e.g., TEGL 4-13). As a result, states are expected to further standardize their performance accountability systems and reports to comply with TEGLs 17-05 and 4-13.

In order to become compliant with both TEGL 17-05 and TEGL 4-13, the State will be implementing modifications to SKIES to capture newly required data and resolve the compliance issues related to common measures reporting.

2. Current SKIES Changes and New Data Capture Requirements (Effective June 30, 2014)

Attachment A provides a list of SKIES changes made in an effort to better align SKIES with data integrity efforts and federal requirements. Most of the changes pertain to the one-time Actual End Date data fix for all services that are point-in-time services (e.g., non-duration services). Refer to Attachment A for more details concerning this group of changes, including the rationale. Certain services are identified as exceptions (e.g., duration services), including training services, and will not be part of this one-time data fix. Refer to Attachment B for a list of duration services that will be identified in the updated Services Catalog (effective June 30, 2014). This one-time data fix will be conducted to close point-in-time services that may be preventing participants from exiting appropriately. Those participants who have not received a qualifying service or self-service for a minimum of 90 days will likely exit. Refer to Attachment C for impact estimates related to this one-time data-fix process.

Attachment A also identifies new data capture and verification requirements. Not all data elements are currently validated (TEGL 28-11) for all programs to which they apply (TEGL 4-13), but it is ESD's strong expectation that these items will be validated uniformly in the future. Please note that the program validation screens differ according to the program that is being validated. Although the scheduled changes will bring the screens into closer alignment, there will still be differences.

NOTE: WDCs should apply the same data capture and verification processes uniformly across programs with the expectation that data validation will be applied uniformly in the future. WDCs should refer to TEGL 28-11 Attachment A or Eligibility Policy 1019 Attachment A (Handbook) for a list of minimum documentation requirements (e.g., self-attestation for low-income).

3. Future Changes and Data Integrity Efforts Following the Implementation of the SKIES Technology Upgrade (STU)

The State plans to implement an on-going batch close process designed to close out open duration services if 90 days has transpired without an additional qualifying service. The batch close process, or soft exit feature, is a necessary step in the larger data integrity effort, but waiting for the implementation of STU will contribute to a smooth transition with less re-work. Therefore, the planned on-going batch close process (soft exit feature) will be delayed pending the completion of STU. Status updates concerning this change, along with the most recent services report, will be communicated as STU nears completion (sometime this Fall).

In addition to existing policy documents on the subject, ESD has the following efforts underway to provide opportunities for staff to engage in the larger data integrity and compliance effort:

Attachment A – SKIES Changes and Data Capture Requirements

Effective Date / Change	SKIES / Reporting Function Impacted	Description of Change	Rationale
6.30.14.a	WIA Program Validation Screens	New fields are required to pass the program validations screens prior to updating the program status to 'participant.' The specific changes are illustrated <u>below</u> this matrix (see page 5).	TEGL 4-13 requires SKIES application changes relating to data collection and program validation screens.
6.30.14.b	Service Plan Service Dates	For all point-in-time services, SKIES will automatically enter the Actual End Date to align with the entered Actual Start Date. After the change, users will not be able to modify Actual End Dates to create durations for point-in-time services. All local services will be classified as point-in-time (non-duration) services. Duration services (see Attachment B) are limited to a specific list of services, and only two of these services are non-training services. A one-time data fix will occur to clean up the existing open ended records that do not fall within the exception criteria (i.e., services that are not 'duration' activities). For this data fix, the Actual End Date will default to the Actual Start Date. The Actual Outcome will default to "Unknown: Service closed per WIN 0061." Planned completion dates will not be modified by this data fix and existing Actual End Dates will not be overwritten. Note: Self-services in the most recent 90 days will have no impact on the logic for closing out an Actual End Date.	The 2013 Department of Labor Data Element Validation report identified that staff were keeping services open for duration of time without actually providing a service. Keeping these services open delayed the participant's exit and therefore artificially altered performance outcomes The SKIES change will NOT eliminate the ability to extend exit via an open service for duration services. The SKIES change eliminates the ability for point-in-time services to be open for a duration of time. This information will allow data validation to verify when actual service delivery occurred.
6.30.14.c	Service Plan Service Dates, Training Services	Although certain services (mostly training related) will be allowed to have a duration entered by staff, federal reporting will ignore planned completion dates when calculating exit dates, while acknowledging Actual End Dates for the calculation. Note: Local services will continue to be ignored for federal reporting.	Also related to DOL Data Validation Finding #1. This change will allow staff to continue managing a training plan to show training services spanning weeks or months. The planned Actual End Dates on those services will be ignored for participation purposes. Only the Actual Start and End Dates will count.
