**SUBJECT:** Distribution of Fiscal Year 2015 Rapid Response funds to local areas to serve additional WIA-eligible dislocated workers

**Purpose:**

To communicate the State’s decision to formula-allocate \$2 million in Fiscal Year 2015 (FY15) Rapid Response funds to bolster local area FY15 WIA Title I-B Dislocated Worker formula allotments.

**Change 1** reflects an updated table that provides the new program and cost pool amounts for your FY15 Dislocated Worker grant packages. The previous table provided the updated Total Dislocated Worker (PY14/FY15) allocations.

**Action Required:**

FY15 WIA Title I-B Dislocated Worker and ACP grant modification packages will soon be issued to each Workforce Development Council (WDC). **Content:**

The State is bolstering local area FY15 WIA Title I-B Dislocated Worker formula allotments with \$2 million in FY15 Rapid Response funds.
